Meeting called to order at 2:05pm by Trish Lounsbury.

- Paul found that the LSC website link for LSC Rules and Regulations linked to the IPCCA R&R's. Helen will change to intended link.
- Trish recommended for us to go through the input regarding R&R's and membership from committee members, Maggie, Helen and staff and discuss. Helen provided a spreadsheet with income received from Fee Members. This equates to approximately \$25,000 annually. *See attached spreadsheet to minutes.**
- R&R's text changes and additions were discussed. *See the attached document outlining suggestions.**
- There was an extensive discussion of existing and potential users. After working through several scenarios of membership and fees the conclusion was to not recommend a change, leaving membership options as currently exists.
- Paul wanted to address if Tennis, Pickleball and Bocce Ball Tournaments can be set up to include nonmembers, outside players from here or other areas. Helen suggested that the request for this be submitted to the Board for approval on a case by case basis. Paul and committee would like to know the process to do this.
- Trish would like Helen to present a status report on how effective the additional signage, new card reader and other improvements have been to secure the LSC facilities are being used by members only.
- Trish suggested LSC sell LSC t-shirts/promotional wear for sale. To be discussed.
- Helen brought up the lack of following the R&R's regarding smoking, including e-cigs and vapes. Especially a bad example when committee members are doing these violations. The committee should be an example, not exhibiting behavior in violation of the R&R's.
- Which brought up the discussion of what happens when these R&R's are not adhered to? This should be determined and added to R&R's.
- Committee agreed we will outline, discuss and submit these R&R recommendations to the Board.
- Committee agreed we will take up the 12-36 month work plan as priority at the next meeting. Trish and Joanie will work on an outline to send to the committee prior to the September meeting and have it ready to submit for the budget deadline.
